**1-Subject:** Acquisition ten (10) TV transmitters for the Wilaya of El Bayadh

**2-Type of tender:** Open national and international tender with requirement of minimum capacity.

**3-Eligibility conditions:** This Open National and International Tender, subject to minimum capacity requirements, is available to bidders who meet the following conditions:

- **First condition:** Have at least one of the following activities:
  - Manufacturer of terrestrial of TV transmission and/or broadcasting equipment duly justified by the legal status documents, extract from the Commercial Register extract, or K-bis certificate.
  - Integrator of terrestrial transmission and/or broadcasting equipment (TV or Radio), duly justified by the legal status documents, extract from the Commercial Register extract, or K-bis certificate.
- **Second condition:**

The bidder must have supplied at least one (01) DTT broadcasting station and/or rebroadcasting duly justified by a certificate(s) of satisfactory completion.
- **Third condition:**

The bidder must have achieved an average annual turnover of at least 40 000 000 Algerian Dinars over the last three (03) years.

Any offer that does not meet all of these requirements will not be qualified.

**Note:** Joint ventures are not permitted for this call for tenders.

**6-Submission date and time limit:** Submission date and time limit: The bid submission date is fixed on the last day of the bid preparation period, from 9:00 am to 01:00 pm. If this date falls on a public holiday or a statutory weekly day of rest (Friday or Saturday), it shall be postponed to the next working day.

**7-Bids validity period:** Tenderers will remain legally bound by their offers for a period of ninety (90) days, increased by the preparation's duration of offers, from the bid submission date.

**8-Required documents:** Bids containing the required documents specified in Article 15 of the tender specifications have to be presented according to the conditions listed under Article 15 of the specifications book.
